## Special Meeting BANNER ELK TOWN COUNCIL April 29th, 2010 MINUTES

The Banner Elk Town Council met Thursday April 29<sup>th</sup>, 2010 at the Banner Elk Town Hall for a special meeting pursuant to N.C.G.S. 160A-71(b).

Council Members present: Mayor Tate, Ms. Draughon, Mr. Phillips and Mr. Hahn.

Staff present: Town Manager John Mejaski, Steve Smith.

#### Call Meeting to Order

Mayor Tate called the special meeting for April 29<sup>th</sup>, 2010 to order at 6:30pm.

### Pledge of Allegiance

Mayor Tate led those in attendance in the Pledge of Allegiance.

### **Invocation**

Mayor Tate opened with prayer.

### Approve Stated Agenda

Mayor Tate asked Council for a motion to approve the agenda. Mr. Hahn requested adding to the agenda the consideration of a resolution approving the concept of a culinary institute. Mayor Tate asked for a second. Mr. Phillips seconded the request made by Mr. Hahn. Mayor Tate called for discussion of the matter. Ms. Draughon stated that a resolution takes a majority of the entire Council and being that there are two Council members absent from the meeting a vote on the resolution can not take place. Mr. Hahn stated that he was requesting the addition to the agenda. Mayor Tate asked Council for a motion to clear the confusion of the request. Mr. Hahn motioned to add to the agenda discussing consideration of a resolution in support of the culinary and wine institute concept. Mr. Phillips seconded Mr. Hahn's motion. Mayor Tate asked if there was any further discussion, being none Mayor Tate called for a vote. Mr. Hahn and Mr. Phillips were in favor. Ms. Draughon opposed (2-1). ### Discussion of a Resolution Supporting the Concept of a Wine and Culinary Institute

Further discussion centered around the idea of supporting one idea over the other and if such was appropriate. In the end Council took no formal action.
