- C. The Owner reserves the right to waive any informalities or reject any or all bids. The Owner reserves the right to award a contract to the lowest, responsive, responsible bidder.
- D. Each prime bidder must be appropriately licensed as a Contractor in the State of North Carolina as provided in General Statutes Chapter 87. All Contractors and sub-contractors are hereby notified that they must have proper license under the State laws governing their respective trades. Single Prime bidders wishing to team, who are only licensed in grading, utilities, and heavy highway construction must identify the building contractor who they will be teaming with. Likewise, building contractors who are not licensed in grading, utilities, and heavy highway construction, must identify there properly licensed teaming sub-contractor. Each bidder shall make positive efforts to use small and minority owned business enterprises as well as local contractors on this project.
- E. All permitting has been secured by the Engineer prior to the start of this project. It shall be the responsibility of the Owner to comply with the attached permit conditions.
- F. A conditional or qualified BID will not be accepted. Only Sealed Single Prime Bids will be accepted.
- G. The winning bidder will be required to submit certificates of insurance naming the Town of Banner Elk as an additional insured.
